EARLY ACHIEVEMENTS TRACK-RECORD

After receiving my PhD from UCL in 2008, I started working in the Department of Economics and Business at Universitat Pompeu Fabra in Barcelona, first as an assistant professor and then, since 2013, as a tenured associate professor. In 2010, I received a Juan de la Cierva fellowship from the Spanish Ministry of Science and Innovation and, in April 2013, I was awarded a José Castillejo grant in support of a three-month research stay at the Department of Economics at UC Berkeley. Between 2014 and 2016, I held a visiting position as a Heisenberg Fellow at Humboldt University Berlin. In 2016, I received a Ramón y Cajal Fellowship from the Spanish Ministry of the Economy. My main research area is labor economics and here, in particular, the economics of migration. However, over the last few years, I have also worked extensively on several projects related to industrial and political espionage, one of which ("Industrial Espionage and Productivity") was published in the American Economic Review in 2020. I am currently an affiliated researcher at the Institute of Political Economy and Governance (IPEG) in Barcelona and an affiliated professor at the Barcelona School of Economics, where I have been teaching graduate courses in econometric methods and the economics of migration for many years. I am also Research Fellow at CEPR, Research Fellow at IZA in Bonn, Research Fellow at the Centre for Research and Analysis of Migration (CReAM) in London, and Research Network Member at CESifo in Munich. Since the start of my academic career, I have given more than 50 invited talks and more than 40 presentations at international conferences around the world. I am currently co-editor of Labour Economics and have served as a referee for more than 40 international journals, including the American Economic Review, the Journal of Political Economy, the Quarterly Journal of Economics and the Review of Economic Studies. As of February 2024, I have received 4,372 citations in Google Scholar (978 in Web of Science, 1,103 in Scopus), resulting in an h-index of 22. According to RePEc's average rank score, I rank in the top 6% of economics researchers in the world and the top 4% in Europe.
